THE NATIONAL GIRLS COLLABORATIVE ALSO OPERATES ON A LOCAL BASIS PROVIDING SUPPORT TO STATE LEADERSHIP TEAMS. EACH COLLABORATIVE HAS A DEFINED REGION, ACTING AS A HUB FOR LOCAL PROGRAMS TO COORDINATE RESOURCES AND REACH GIRL-SERVING STEM PROGRAMS IN THE COMMUNITY. THE NATIONAL GIRLS COLLABORATIVE PROVIDES A DIRECTORY OF GIRL-SERVING STEM PROGRAMS AND ALLOWS THOSE PROGRAMS TO BROADCAST THEIR ACTIVITY WITH EVENTS AND NEWS. CURRENTLY, 33 NGC COLLABORATIVES SERVE 41 STATES, FACILITATING COLLABORATION BETWEEN 42,500 ORGANIZATIONS WHO SERVE 20.20 MILLION GIRLS AND 14 MILLION BOYS.
