THE NATIONAL GIRLS COLLABORATIVE ALSO OPERATES ON A LOCAL BASIS PROVIDING SUPPORT TO STATE LEADERSHIP TEAMS. EACH COLLABORATIVE HAS A DEFINED REGION, ACTING AS A HUB FOR LOCAL PROGRAMS TO COORDINATE RESOURCES AND REACH GIRL-SERVING STEM PROGRAMS IN THE COMMUNITY. THE NATIONAL GIRLS COLLABORATIVE PROVIDES A DIRECTORY OF GIRL-SERVING STEM PROGRAMS AND ALLOWS THOSE PROGRAMS TO BROADCAST THEIR ACTIVITY WITH EVENTS AND NEWS.
