THE NATIONAL GIRLS COLLABORATIVE ALSO OPERATES ON A LOCAL BASIS PROVIDING SUPPORT TO STATE LEADERSHIP TEAMS. EACH COLLABORATIVE HAS A DEFINED REGION, ACTING AS A HUB FOR LOCAL PROGRAMS TO COORDINATE RESOURCES AND REACH STEM PROGRAMS IN THE COMMUNITY. CURRENTLY, 33 NGC COLLABORATIVES SERVE 41 STATES, FACILITATING COLLABORATION BETWEEN 42,500 ORGANIZATIONS WHO SERVE 20.20 MILLION GIRLS AND 14 MILLION BOYS.
